The Delhi Metro Rail Corporation (DMRC) Ltd, a Joint Venture company with equity participation from Govt. of India and Govt. of National Capital Territory of Delhi has been entrusted with the responsibility of implementation of the rail based Mass Rapid Transit System for Delhi. The **Delhi Metro Rail Corporation, Lifeline of Delhi**, prides itself on its ability to nurture its employees through its unique work culture. Today, DMRC empowered by about 8000 employees with MRTS activities spread over Delhi NCR, Jaipur, Kochi etc. carry more than 2.5 million passengers every day in Delhi & NCR. In addition to the above, DMRC has also been entrusted with the work of preparation of DPR for the High Speed Rail Link Project of Indian Railways at Trivandrum and the Monorail Project at Trivandrum and Kozhikode and consultancy work for different cities in India like Lucknow, Ahmadabad and abroad too like Jakarta, Dhaka etc.

To meet with the immediate requirement of experienced personnel for DMRC and its allied projects, applications are invited from retired/experienced, dynamic and motivated persons of Indian nationality, having relevant experience and working, for the following category of **Executive and Non-Executive posts in DMRC on Re-employment /contract basis for a period of three years (extendable on year to year basis)**. Officers /Supervisors working/retired from Railway/Railway PSUs/ Govt/PSUs involved in construction are eligible to apply.

Important:

*Those candidates who have superannuated will be considered for induction on **re-employment basis** only and will be eligible for consolidated fee and other allowance as per Company policy.*

Candidates selected on contract basis will be fixed at the minimum of the pay scale and will be eligible for DA, HRA and perks @ 45% and any other allowances as per Company Policy

Selection process :

The selection methodology will comprise two stage processes –Personal Interview followed by Medical examination, as per Company Policy. The selection process would judge different facets of knowledge, skills, experience, expertise, aptitude and physical fitness. The candidates may be shortlisted for interview, based on their eligibility, experience in the relevant field, tentatively in the ratio of 1:5.

Medical Examination:

The candidate selected on contract basis will have to undergo medical fitness examination in DMRC prior to joining. **No reimbursement on account of travel shall be made to the candidates appearing for the INTERVIEW.**

How to apply:

Eligible and interested candidates may apply as per the application format at Annexure-I. All relevant documents can be attached with the application regarding.

Schedule of Selection Process:

1. The complete filled in application form should reach this office latest by **24/03/2015**.
2. Names of shortlisted candidates will be put up on our website on **08/04/2015**.
The shortlisted candidates will have to appear for interview on the scheduled dates and time with all original documents /testimonials and experience certificates.

The interview will tentatively start in **third week of April 2015, at Metro Bhawan, Barakhamba Road, New Delhi**. No separate communications by post will be sent to the candidates individually. The candidates are required to go through the instructions for interview displayed on our website and appear for the interview accordingly along with original copies of testimonials. The candidates should be in constant touch with DMRC website **www.delhimetrorail.com** for updated information.

3. The names of the candidates, who qualify the selection process, will be uploaded in our website tentatively one week after holding of interview.
4. The shortlisted candidates will be sent for medical examination.
5. The detailed form to be filled up is enclosed. The candidates shall submit the filled in format and attach two copies of recent passport size photos and all the relevant documents and testimonials.
6. Incomplete applications or applications received after the due date will be summarily rejected. DMRC is not responsible for Loss/delay in post.
7. DMRC is not responsible for any printing error that might have inadvertently crept in.

The candidate who are presently working and will be retiring by 2016 will have to submit an undertaking at the time of interview that they will resign/take Voluntary Retirement from the existing post to take up re-employment with DMRC
