The Delhi Metro Rail Corporation, Lifeline of Delhi, prides itself on its ability to nurture its employees through its unique work culture. **1. EXPERIENCE CRITERIA (AS ON 01/01/2020): -**

**A. Pay Scale criteria -**

**(i) For employees serving in Central Government organization / CPSU in CDA pay scales**

Officer of Central Government Organization / CPSU in CDA pay scale of Level 14, working in Civil department.

**(ii) For employees serving in Government organization / CPSU in IDA pay scales**

Officer of Central Government Organization / CPSU in IDA pay scale of E 8 - Rs. 51,300-73,000 (pre-revised) or Rs. 1,20,000-2,80,000 (revised), working in Civil department.

**B. Work experience criteria -**

The candidate should have varied experience of working in Railways / CPWD / BSNL / Other PSUs / Other Metro Organizations in its Civil / Construction department and should be conversant with functioning in computerized environment. Hands on knowledge of various computer applications, relating to the job is desirable.

## **2. PAY AND EMOLUMENTS:**

The selected candidate on deputation will continue to draw parent department pay plus deputation allowance, as applicable, under the Govt. of India rules.

## **3. SCHEDULE OF SELECTION:**

- i. Last date of receipt of **duly filled in application** (along with relevant documents), **necessarily forwarded by the current organization, OR, along with No Objection certificate**, through Speed post is **10/02/2020**. Incomplete applications or applications not duly forwarded by current organization / without NOC, or, applications received after the due date, will be summarily rejected. DMRC shall not be responsible for loss / delay in post.
- ii. **The list of shortlisted candidates shall be uploaded on DMRC website in the last week of February, 2020 (tentatively) and interview will be held in the second week of March, 2020 at Metro Bhawan, Barakhamba Road, New Delhi (tentatively)** (Complete details will be displayed on DMRC website).
- iii. No separate communication, by post, will be sent to the candidates individually. Candidates are required to go through the instructions / schedule for interview displayed on DMRC website and appear for the interview, accordingly, along with original copies of testimonials.
- iv. **The final result will be declared by the third week of March, 2020 (Tentatively).**

Eligible and willing candidates for the aforesaid post may apply as per the application format at Annexure-I. The candidate must enclose all relevant proof / documents in support of qualification, experience, pay and pay scale.

The candidates should send their application through proper channel along with the copies of APARs for the last five years along with Vigilance and D&AR clearance, so as to reach the under mentioned address by the stipulated date. The applications received after the due date will be summarily rejected.

The candidates shortlisted for the Screening Process will be advised through DMRC website only and will be eligible for re-imbursalment of train fare by ACIII tier.
