2. Eligibility Criterion:

DGM / Manager (S&T)

I. Essential Experience

- Project Experience of modern signaling systems in Metro / Railways i.e. EI / TMC / CTC / Route Relay Interlocking.
- Experience of Signal & Control table / TPWS / TMS and safety circuits design in railway / metro rail signaling applications.

II. Desirable Experience

- Experience of 3-5 years in Data Presentation / Review of Data of EI / ATC / ATS / TMS / TPWS / Control Tables / Algorithms used in these sub-systems.
- Experience in Software tools for the above-mentioned activities.

NOTE – The candidates are required to submit a certificate of experience in the given field and work done in these fields; including the projects, where candidate has worked in these fields.

3. Screening process:

The screening methodology will comprise of Personal Interview. The screening process would judge different facets of knowledge, skills, experience, expertise, aptitude and ability. The candidates will be shortlisted for interview, based on their eligibility / relevant work experience, in the ratio of 1:5, subject to availability of candidates.

No reimbursement on account of travel shall be made to the candidates appearing for the INTERVIEW.

4. Schedule of selection:

- a. Last date of receipt of duly filled in application (along with relevant documents) through Speed post is **10/12/2019**. Incomplete applications or applications received after the due date will be summarily rejected. DMRC shall not be responsible for loss / delay in post.
- b. **The list of shortlisted candidates shall be uploaded on DMRC website in last week of December 2019 (tentatively) and interview will be held in the second week of January, 2020 at Metro Bhawan, Barakhamba Road, New Delhi (tentatively) (Complete details will be displayed on DMRC website).**
- c. No separate communication, by post, will be sent to candidates individually. Candidates are required to go through the instructions / schedule for interview displayed on DMRC website and appear for the interview, accordingly along with original copies of testimonials.
- d. **The final result will be declared by third week of January, 2020. (Tentatively).**

Eligible and willing candidates for the aforesaid post may apply as per the **application format** at **Annexure-I**. The candidate must enclose all relevant documents in support of qualification, work experience, pay & pay scale (last drawn, in case of superannuated candidates). The certificate of experience submitted must clearly indicate experience in the given field and work done including the projects where applicants have worked in these fields.

The candidates presently employed in Railways / Govt. organizations / Public Sector Undertaking (PSUs) should send their application through proper channel along with Vigilance and D&AR clearance, so as to reach the below mentioned address within the stipulated time. All candidates are required to submit copies of their APARs for the last five years
