DMRC OPEN MARKET RECRUITMENT, 2019 – REDUCTION IN VACANCIES, reg.

DMRC had launched an Open Market Recruitment, in terms of the Advertisement No. DMRC/HR/Rectt./I/2019, dated: 14/12/2019 (read with Addendum – I, dated: 01/01/2020), for a total of 1493 vacancies, spread across 38 categories of posts (regular and contractual). The Computer Based Tests (CBTs), were held between 17/02/2020 and 26/02/2020 and in keeping with the DMRC's exacting standards, the Results/Panels came to be notified, w.e.f. 06/04/2020, amidst the nationwide lockdown.

II. The process, however, had to be halted midway and a review undertaken, in view of the telling effect of the pandemic on DMRC's operations and finances. As is well known, DMRC's operations were suspended w.e.f. 22/03/2020 and continued to be so, till 06/09/2020 – for a total of 169 days. Sometime prior to the suspension and even after the re-opening, DMRC's ridership had/have taken a big hit. The situation would take quite some time to stabilise/normalise, as is foreseen.

III. Both the fare and the non-fare box revenues, have been severely impacted, as a result. In addition, DMRC has had to incur extra expenditure, by way of preventive measures to offset the effect of the pandemic. Work processes have been re-defined and reviews across DMRC's work centers/activities, have been undertaken, as required. Cost cutting measures have also been put in place, as a result thereof. This also necessitated a review of the DMRC's ongoing recruitment exercise and the details thereof, is as at Annexure-I.

IV. DMRC fully empathises with the candidates who have been de-panelled/have been affected, as a result of the reduction in the vacancies and appreciate their sentiments in the matter. DMRC has been constrained on account of the compelling circumstances, arising out of the pandemic, in effecting the reduction and hopes to engage with the candidates in the future, on a more pleasant and happy note. To address the various issues that may be engaging the mind of the candidates, FAQs have been prepared, as at Annexure-II.

V. Candidates may like to look up the FAQs, as required and not fall prey to rumours about the recruitment, that are being spread by certain vested interests, alleging issues that are beyond the pale of the instant recruitment. All concerned may rest be assured that the recruitment process in DMRC is robust, computerised, transparent and purely, merit based. Candidates are also advised to keep in regular touch with the official website of the DMRC, for the latest updates regarding the recruitment and the issues, thereof.

| 1. | How can one check the latest updates regarding the 2019 recruitment? | Candidates may visit the Career section of the official website of DMRC: www.delhimetrorail.com , for the latest updates on the matter. |
| 2. | Can the advertised number of vacancies increase or decrease? | As notified in the Advertisement, dated: 14/12/2019, all vacancies were provisional and subject to increase/decrease, depending on the requirement/s. |
| 3. | Why have/are the advertised vacancies been/being reviewed/reduced? | In view of the COVID-19 pandemic situation, there has been an overall reduction in the activities of DMRC. Due to the total suspension of DMRC's metro operations for 169 days and the current massive reduction in ridership, DMRC has incurred severe financial loss. Conversely, extra expenditure have been/are being incurred on account of the preventive measures necessitated by the pandemic. Accordingly, the man-power requirements have been reviewed, leading to reduction in the requirement, across the various Departments of DMRC. |
| 4. | Why did DMRC issue panels/results during the lockdown period when manpower requirements were to be reviewed? | The panels/results were issued as DMRC had endeavored to complete the recruitment process, as early as possible. The extent and the effect of the prevalent COVID-19 pandemic situation was, however, unforeseen, leading to a review of the requirements. |
| 5. | Can I view my Response Sheet and Score Card? | The Score Card and the Response Sheet of the candidates, who appeared in the CBT for a post whose final result has been declared, have been provided, vide Notice, dated: 14/05/2020. For the remaining categories of posts, as & when the final result is published, i.e., upon finalization of GD &/or Interview, Psychometric Test, Skill Test, as applicable, the Score Card and the Response Sheet of the candidates, would be released. | 6. | What is the status of recruitment action for the post of Customer Relations Assistant, which has been kept in abeyance? | As indicated in the Notice, dated: 14/07/2020, available on the official website of the DMRC, recruitment action for the post of Customer Relations Assistant (CRA) – RNE10, has been kept in abeyance, till further notice, and shall be subject to review of requirement, subsequently.
