NOTICE INVITING TENDER

Delhi Metro Rail Corporation Limited (DMRC) invites tenders from eligible applicants for the following work :

NIT No. DMRC/CPM -East/Kaushambi & Vaishali/545 : Contract BASG-VLI-EXT : Manufacture, supply, installation, testing and commissioning of signage and graphics for Kaushambi & Vaishali Stations (Yamuna Bank – Anand Vihar Corridor Extension upto Vaishali, Ghazibad)

Approximate cost of the work : 40.00 Lakhs
Completion period : 2 (Two) months.

Minimum Eligibility Criteria:

A. Work Experience:

The applicant should have completed work(s) during last seven years ending 31.01.2011 as given below:

- (a) At least one single work of “Signage and Graphics or Signage and Graphic works of Metro Station” of value of Rs.32.00 lakhs or more, **or**
- (b) Two different works, as defined in para (a) above, each of value Rs.20.00 lakhs or more, **or**
- (c) Three different works, as defined in para (a) above, each of value Rs.16.00 lakhs or more.

B. Financial Standing:

The applicant should have minimum financial capabilities as below:

- (a) Profit before tax should be Positive in at least 1 (one) Year, out of the last three years.
- (b) The average annual turn over of last three financial years should be > Rs.1.92 crores.

For the minimum eligibility criteria, value of successfully completed portion of any ongoing work will also be considered. In case of Joint Venture/Consortium, the works done either by the same joint venture or total of any one work in case of i. a) or two

works in case of i. b) or three works in case of i. c) of each member of the joint venture shall be considered for this criteria. The work of each member, if done in joint venture will be taken as per the percentage participation.

Only those applicants (proprietary / partnership firms, limited companies, consortia, joint ventures etc.), who fulfil the minimum eligibility criteria need to apply. A firm, who has purchased the tender document in their name, can submit the tender either as individual firm or as a joint venture/consortium.

One-set of tender document (Non-transferable) can be purchased from the office of **Chief Project Manager/East**, Seed Bed Park, Opposite Gurudwara, Shakarpur, Delhi 110092 from 21.02.2011 to 11.03.2011 on all working days except Sundays and holidays between 0930 hrs. to 1730 hrs. on payment of a non-refundable fee of Rs.5,250/- (Rupees Five Thousand Two Hundred Fifty Only) (inclusive of 5% DVAT) in the form of a crossed demand draft, drawn in favour of Delhi Metro Rail Corporation Ltd. payable at New Delhi.
