4. You shall ensure full compliance with Tax Laws of India with regard to this contract and shall be solely responsible for the same. You shall keep the employer fully indemnified against your liability of tax, interest, penalty etc. in respect thereof which may arise.
5. Dy.Chief Engineer/Track-I of this organization will be the Engineer for this contract.
6. You are requested to contact the Dy.Chief Engineer/Track-I immediately for further necessary action in this matter and to commence the work within 7 days from the date of issue of this L.O.A.
7. All the works shall be executed in accordance with the specifications stipulated in Tender document.

8. It may please be noted that until a formal agreement is executed, this letter will constitute a binding Contract between you and DMRC. Please take necessary action as required vide Clause Nos. F4 and F5 of Instructions to Tenderers (ITT) regarding signing of agreement within 45 days from the date of issue of letter of acceptance and submission of performance security within 30 days from the date of receipt of LOA.
9. In case you are willing to submit the performance security in the form of Bank Guarantee, it is mentioned that the same should be submitted as per Revised Annexure-6 of ITT i.e. "Form of Performance Security (guarantee) by bank" attached herewith.
